FAMILY HOMELESSNESS PREVENTION PROGRAM: CHGM PROVIDED HOUSING STABILIZATION SERVICES TO 656 FAMILIES AT IMMINENT RISK OF HOMELESSNESS, INCLUDING 656 ADULTS AND 1062 CHILDREN. 91% OF THE FAMILIES WE SERVED WERE ABLE TO AVOID A SHELTER STAY.

HOUSING PROGRAMS: OUR RAPID REHOUSING PROGRAM SUPPORTED 79 FAMILIES TRANSITIONING OUT OF HOMELESSNESS, INCLUDING 111 ADULTS AND 147 CHILDREN. OUR MEDICAL OUTREACH PROJECT WITH UNITY HEALTHCARE SERVED 103 INDIVIDUALS THROUGH 158 INTERACTIONS. WE HELPED 10 CHRONICALLY HOMELESS INDIVIDUALS MOVE INTO THEIR OWN APARTMENTS.
